

**KICKING4HUNGER  
RELEASE AND HOLD HARMLESS AGREEMENT**

As part of the consideration for my granting permission for my child's participation in all regularly-scheduled activities of Kicking4Hunger, a North Carolina nonprofit 501(c)3 corporation, I hereby release, hold harmless, and forever discharge Kicking4Hunger, its employees and agents, and volunteers from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, property damage, or personal injury, including death, that may be sustained by my child or to any property belonging to my child while participating in the activity described below.

I am fully aware that soccer is a physical and dangerous sport and entails known and unanticipated risks which could result in physical injury, paralysis, death, or damage to self, to property or to third parties and that these risks cannot be entirely eliminated without jeopardizing the essential qualities of the activity. I acknowledge that my child's participation in this activity is requested and elected by me and is not required in any way. I voluntarily assume full responsibility for any risk of loss, damage or personal injury, including death that may be sustained by my child as a result of participating in this activity. The undersigned hereby release, waives, discharges and covenant not to sue participants from any and all liability to the undersigned on account of injury to the persons; further I agree to indemnify and save and hold harmless Kicking4Hunger and I \_\_\_\_\_ hereby assume full responsibility for risk of bodily injury due to the negligence or gross negligence of the Release while my child is under the instruction of Kicking 4 Hunger.

This release and hold harmless agreement is binding on me, my heirs, assigns, and personal representatives.
